

Information Standards Notice – Conversion

Following recommendation by the Standardisation Committee for Care Information (SCCI), NHS England has provided authority to publish the following information standard under section 250 of the Health and Social Care Act 2012.

This information standard was formerly approved by the Information Standards Board for Health and Social Care (ISB).

Description	<p>This information standard provides a set of requirements suitably structured to promote and ensure the effective application of clinical risk management by those health organisations that are responsible for the deployment, use, maintenance or decommissioning of Health IT Systems within the health and care environment.</p> <p>The standard includes implementation guidance and is supported by the related standard for the application of clinical risk management in the manufacture of Health IT Systems (SCCI0129).</p> <p>Version 2.0 of this information standard was approved by ISB in February 2013. In April 2014, SCCI replaced ISB; it makes recommendation to the Department of Health and / or NHS England on the publication of information standards. In this instance, SCCI has worked with the developer to assure that this information standard is fit to be published under section 250 of the Health and Social Care Act 2012 without making changes to the content of the information standard.</p> <p>Note that Version 2.0 has been updated to Version 3.0 to align with the developer's configuration management.</p>

Applies to	<p>This information standard is addressed to health organisations that are responsible for ensuring clinical safety in the deployment, use, maintenance or decommissioning of Health IT Systems through the application of clinical risk management.</p> <p>It applies to those Health IT Systems that are not controlled by medical device regulations, though the requirements defined in this standard are broadly consistent with the requirements of ISO</p>
