Background:

The NHS Continuing Healthcare Patient Level Data Set was approved by the Data Coordination Board (DCB) as DCB2117 Amd 7/2018.

A corrigendum is required to the NHS Continuing Healthcare Patient Level Data Set which includes:

- Change to notation status for Data Element CARE PACKAGE REVIEW DATE
- Change in Format/Length for Data Element CONTRACT UNIT COST (NHS CONTINUING HEALTHCARE) and NUMBER OF COMMISSIONED WEEKLY HOURS OF CARE (NHS CONTINUING HEALTHCARE)
- Rename four Data Elements to reflect the closure of Clinical Commissioning Groups from 1st July 2022
- Change in wording in three data items to replace the word "review" with "request".

This Change Request updates the NHS Continuing Healthcare Data Set and supporting definitions to the NHS Data Model and Dictionary to support the Information Standard.
