	Quality assessment	The statistical output is published with an accompanying data quality statement which highlights any underlying issues discovered with the data. Data quality reporting is also published at individual data provider level.
	Periodicity of release	Monthly
	Potential impact of changes to the source on the statistics produced	Substantive changes to source data will result in breaks in time series data. For example, new diagnosis codes or changes in geographical boundaries. MHLDDS has now been superseded by the Mental Health Services Data Set (MHSDS). New statistics based on MHSDS will be available from the Mental Health Services Monthly Statistics publication series.
	Procedures for mitigating such discontinuities	Discontinuities are assessed on an individual basis and are explained and footnoted in publications.
