INTRODUCTION:

- (A) The UK Secretary of State for Health ("**Authority**") has overall responsibility for the delivery and improvement of health and social care. NHS England, is an executive non-departmental public body for the Department of Health.
- (B) NHS England is (a) the owner or licensee (with rights to sub-licence) of intellectual property rights subsisting in a range of clinical content materials (including all supporting documentation or instructions provided for use of those materials)("Content"); or (b) making the Content available where intellectual

property rights subsisting in that Content have expired; or (c) otherwise making the Content available for use by the Licensee at the Licensee's own risk.

- (C) The Licensee is (a) directly involved in the delivery and improvement of health and/or social care ("**End User**"); or (b) a contractor, subcontractor or service provider involved in providing hardware, software or other goods or services to End Users ("**Service Provider**"); or (c) otherwise involved in the delivery and improvement of health and/or social care and wishes to use the Content for that purpose (all "**Permitted Purposes**") in hard copy and/or electronic form (including within hardware and software).

THE PARTIES AGREE as follows:

1. General Terms and Content Specific Terms

- 1.1 NHS England has agreed to make the Content available to the Licensee on the terms set out in this agreement ("**General Terms**") together with any terms which are specific to any piece of the Content ("**Content Specific Terms**").
- 1.2 The Licensee shall sign these General Terms and send them to NHS England by emailing a copy to Clin.Licences@nhs.net (including the Licensee's name in the email subject).
- 1.3 The Licensee acknowledges and agrees that these General Terms shall not come into force unless and until also signed by NHS England. If signed by NHS England, NHS England shall email a countersigned copy to the Licensee to the email address given on page 1 above, following which the Licensee shall be entitled to apply to NHS England to access pieces of the Content through the website <https://digital.nhs.uk/National-Clinical-Content-Repository> ("**Website**") or such other website or mechanism put in place by NHS England (or any successor body or bodies) from time to time.
- 1.4 The Licensee further acknowledges and agrees that even if NHS England countersigns these General Terms, NHS England is in no way obliged to agree to any application by the Licensee to access particular pieces of the Content and that permission from NHS England to access any one piece of the Content does not amount to permission to access all of the Content or to access that Content from sources other than the Website.
- 1.5 Where NHS England does agree to an application by the Licensee and provides access to the relevant piece of the Content, the Licensee's use of that Content is dependent upon the Licensee complying at all times with these General Terms and any Content Specific Terms. The Licensee shall be deemed to have accepted the Content Specific Terms if they view, download, print or use the relevant Content supplied under them. If the Licensee does not agree with the Content Specific Terms the Licensee must immediately notify NHS England as such and must not use the relevant Content, and must destroy or delete any and all copies of that Content in its possession or control (whether in hard copy form or within any hardware or software) and comply with any other instructions given by NHS England.
- 1.6 In the event of conflict or uncertainty between these General Terms and any Content Specific Terms, the provisions of the Content Specific Terms shall take priority.

2. Grant of Licence

- 2.1 Subject to NHS England agreeing to an application by the Licensee to access a particular piece of the Content, in consideration of the sum of £1 (one pound sterling), the receipt and sufficiency of which NHS England acknowledges, NHS England grants the Licensee a revocable, non-exclusive, royalty-free licence to carry out the acts specified below in relation to that piece of the Content:
- 2.1.1 use, reproduce, distribute, perform, display, transmit, publish and view that Content in hard copy form or within any hardware or software (including software for mobile devices) for the Permitted Purpose;

- 2.1.2 implement (but not unduly copy, modify or alter) the methods, logic, algorithms, systems and principles associated with that Content, in hard copy form or within any hardware or software (including software for mobile devices) for the Permitted Purpose;
 - 2.1.3 copy, modify, alter or create derivative works from that Content, but only to the extent required for the Permitted Purpose and in a manner which respects NHS England's or any third party's ownership of that Content and as limited by the requirements under clauses 2.2 and 3 below; and
 - 2.1.4 subject to the provisions of clause 3, copy, download, incorporate, reproduce, develop, modify or customise all or any part of that Content (including any of the text, font, images, diagrams, layout and other part of that Content) for use within any computer systems, hardware or software (including clinical software applications and software for mobile devices) which are developed and delivered for the Permitted Purpose.
- 2.2 The Licensee hereby agrees in relation to all pieces of the Content that it shall:
- 2.2.1 only use the Content for the Permitted Purpose and no other purpose;
 - 2.2.2 only use the Content in the United Kingdom or such other territory expressly stated under "Territory" in each of the Content Specific Terms;
 - 2.2.3 acknowledge the owner of the Content by using any text expressly stated under "Attributions" in each of the Content Specific Terms and not remove or alter any Attributions or other proprietary notices embedded within the Content;
 - 2.2.4 use the Content in accordance with any requirements expressly stated under "Stipulations" in each of the Content Specific Terms and any other requirements that NHS England may communicate to the Licensee from time to time;
 - 2.2.5 only supply or otherwise make available the Content to a person (which, for the remainder of these General Terms and the Content Specific Terms, includes any individual, firm, partnership, trust, corporation, government or governmental body, authority, agency, unincorporated body, association or organisation) who:
 - 2.2.5.1 is a member of the public and a recipient of health and/or social care goods or services; or
 - 2.2.5.2 is involved in the Permitted Purpose and can prove they have already entered into their own General Terms with NHS England and been supplied the Content Specific Terms directly by NHS England;
 - 2.2.6 not sell or impose any fees or charges for use of the Content on any members of the public who are recipients of health and/or social care goods or services or any other person who is involved in the Permitted Purpose;
 - 2.2.7 not incorporate any of the Content into any software (including clinical software applications and software for mobile devices) tools, CDs, USBs or other forms of media or websites which could become accessible to general members of the public or any person not involved in the Permitted Purpose;
 - 2.2.8 continually assess the applicability of, and then comply with, all relevant laws, regulations and good industry practice in relation to medical devices, where it incorporates, supplies or otherwise make available the Content in such a manner that the Content or any part thereof becomes a "medical device" (as defined by the Authority or the Medicines & Healthcare products Regulatory Agency or successor bodies from time to time) and, further, obtain written confirmation from any and all of the Licensee's suppliers of such suppliers' own compliance with the same;

- 2.2.9 notify NHS England immediately (through the email account Clin.Licences@nhs.net) if the Licensee becomes aware of any unauthorised access to, or use of, the Content by any person;
 - 2.2.10 notify NHS England promptly (through the email account Clin.Licences@nhs.net) of any changes to its name or address, and any material changes to its operations such that it is no longer involved in the Permitted Purpose;
 - 2.2.11 comply with any and all applicable laws, regulations and good industry practice in relation to the exercise of the Licensee's rights under these General Terms (and any Content Specific Terms) and use of the Content (including but not limited to all applicable laws, regulations and good industry practice in relation to medical devices, as they apply to the Licensee and/or its suppliers, and the creation, maintenance and destruction of derivative works of the Content containing data of a member of the public); and
 - 2.2.12 obtain any and all necessary consents, licences, certificates and regulatory approvals for its intended use of the Content within the rights granted under clause 2.1 above.
- 2.3 The licence granted under clause 2.1 applies to any revised or replacement version of the Content ("**Revised Content**") that NHS England may make accessible on the Website or otherwise provide to the Licensee from time to time, but not to any Revised Content that the Licensee may independently obtain. The Licensee acknowledges that NHS England is under no obligation to provide Revised Content to the Licensee, but where such Revised Content is provided by NHS England, the Licensee must use reasonable endeavours to use that Revised Content and these General Terms (and any Content Specific Terms) shall apply to any such Revised Content.
- 2.4 Nothing in these General Terms or any Content Specific Terms shall transfer, or purport to transfer, to the Licensee any ownership of the copyright or other intellectual property rights in any of the Content.
- 2.5 The Licensee acknowledges that any intellectual property rights in any trade marks, graphics and logos used on or in connection with any of the Content belong to NHS England and/or its licensors, and that the Licensee is granted no right to use them other than as permitted by these General Terms, any Content Specific Terms or as otherwise permitted by law.
- 2.6 If at any time the Licensee wishes to use a particular piece of the Content outside of the terms of these General Terms and any Content Specific Terms, the Licensee must first obtain the prior written permission of NHS England by sending a request for an extended licence to Clin.Licences@nhs.net. Unless specified otherwise, all terms in these General Terms and any Content Specific Terms shall apply to any such extended licence.

3. Incorporation of the Content into computer systems

- 3.1 The Licensee is permitted under clause 2.1.4 above to make the Content available on computer systems and to incorporate the Content into clinical software applications for the Permitted Purpose, but is responsible for ensuring in relation to all pieces of the Content that:
- 3.1.1 the Content is incorporated safely and that it retains its original clinical integrity;
 - 3.1.2 the Licensee makes only those modifications that are necessary to make the Content available on computer systems or to incorporate the Content into clinical software applications, complying at all times with any Stipulations for the Content (as expressly stated in any Content Specific Terms or as communicated by NHS England to the Licensee from time to time);
 - 3.1.3 any computer system or clinical software application making use of the Content is appropriately tested and conforms with the expected outputs before clinical use;
 - 3.1.4 appropriate training and guidance is provided to users before their usage of any computer systems or clinical software application incorporating the Content;

- 3.1.5 any Attributions or applicable Stipulations for the Content (as expressly stated in any Content Specific Terms) must appear both on screen to users of any computer systems or clinical software application incorporating the Content and also on any copies of the Content when printed; and
- 3.1.6 any third party involved in making the Content available on computer systems or incorporating the Content into clinical software applications (either as a Service Provider where the Licensee is an End User or an End User where the Licensee is a Service Provider or in any other manner involved) must have been identified by the Licensee to NHS England and entered into their own General Terms with NHS England and been supplied the Content Specific Terms directly by NHS England prior to any such incorporation by that third party and/or the Licensee supplying the Content (in its original form or as modified in accordance with these General Terms and any Content Specific Terms) to that third party.
- 3.2 NHS England requires that no charge should be payable, as between the Licensee and any third parties in relation to use of the Content itself, but nothing in these General Terms or the Content Specific Terms (unless expressly stated therein) prevents any other form of commercial dealings between those parties or charges for goods and services which may involve the Content.
- 3.3 The Content is provided "as is" and "as available" without warranty or any guarantee that it will meet individual requirements. Other than expressly set out in these General Terms and any Content Specific Terms, NHS England makes no representations or warranties, express or implied, including any warranties of accuracy, timeliness or fitness for a particular purpose in relation to the Content or that the Content is up to date. To the extent permitted by law, NHS England expressly excludes all conditions, warranties and other terms which might otherwise be implied by statute, common law or the law of equity.
- 3.4 If the Licensee's use of the Content or making the Content available on computer systems or incorporating the Content into clinical software applications results in the need for servicing, repair or correction of hardware, software or data of the Licensee, as between NHS England and the Licensee, the Licensee shall assume all responsibility for doing so and the costs thereof (subject to any separate commercial dealings in place with any third parties).
- 4. Termination**
- 4.1 The Licensee acknowledges that these General Terms and any Content Specific Terms and the licence granted under clause 2.1 in relation to all pieces of the Content will automatically terminate if any of the following events occurs:
- 4.1.1 the Licensee fails to comply with the conditions set out in clause 2.2 or breaches any of provisions of these General Terms or any Content Specific Terms; or
- 4.1.2 the Licensee ceases, whether by choice or as a result of an insolvency event, to be involved in the Permitted Purpose; or
- 4.1.3 the Licensee has provided any piece of the Content to a third party that has not first entered into their own General Terms with NHS England and been supplied the Content Specific Terms directly by NHS England (except as provided for in clause 5.3 below); or
- 4.1.4 NHS England determines in its absolute discretion that the Licensee has acted in an inappropriate or unlawful manner.
- 4.2 The Licensee acknowledges that these General Terms and any Content Specific Terms and the licence granted under clause 2.1 will immediately terminate in relation to a specific piece of the Content upon written notice posted on the Website (or otherwise communicated by NHS England) if any of the following events occurs in relation to that specific piece of the Content:

- 4.2.1 any licence granting NHS England permission to sub-licence use of that Content is, for whatever reason, terminated; or
- 4.2.2 NHS England and/or the Authority determine, for whatever reason and in their absolute discretion, that the relevant Content should no longer be used.

- 4.3 In the event of termination the Licensee must immediately cease all use of the Content (either all of the Content in the case of termination under clause 4.1 or just the relevant pieces of the Content in the case of termination under clause 4.2) and must comply with all applicable laws, regulations and good industry practice in relation to the preservation of medical records, but must otherwise destroy or delete any and all copies of that Content in its possession or control (whether in hard copy form or within any hardware or software) and comply with any other instructions given by NHS England.
- 4.4 The provisions of clause 6.3 (the Licensee's indemnity to NHS England) shall continue to apply after termination of the Licensee's right to use the Content.

5. Sub-Licences

- 5.1 NHS England may sub-licence the rights granted under clause 2.1 to the Authority, an Authority Party or any other person for the Permitted Purpose.
- 5.2 The Licensee shall not sub-licence the rights granted under clause 2.1 to any other person without the prior written permission of NHS England, except that where the Licensee is an End User, they may informally and impliedly sub-licence the rights granted under clause 2.1 to members of the public who are recipients of health and/or social care goods or services but only for the Permitted Purpose in accordance with these General Terms, any Content Specific Terms and any applicable laws, regulations and good industry practice.
- 5.3 For the avoidance of doubt, no sub-licence from the Licensee, nor a further licence from NHS England, is required in the event a derivative work of the Content containing data of a member of the public needs to be transferred to any other health and/or social care provider for that specific person's on-going care.

6. Liability

- 6.1 The Licensee acknowledges that the provision of a piece of the Content does not indicate endorsement or clinical assurance of that Content by NHS England, the Authority or any Authority Party or any clinical professional body unless there is an explicit statement to the contrary within the Content itself or the relevant Content Specific Terms.
- 6.2 NHS England, the Authority and any Authority Party shall not be liable for any liabilities, costs, expenses, damages and losses incurred by the Licensee (or any members of the public who are recipients of the Licensee's goods or services or any other person) arising out of or in connection with the Licensee's exercise of the rights granted under these General Terms (and any Content Specific Terms) or any use or misuse of any piece of the Content.
- 6.3 The Licensee shall indemnify NHS England (NHS England's licensors, NHS England's sub-licensees, the Authority and any Authority Party) against any liabilities, costs, expenses, damages and losses incurred by NHS England (NHS England's licensors, NHS England's sub-licensees, the Authority and any Authority Party) arising out of or in connection with the Licensee's exercise of the rights granted under these General Terms and any Content Specific Terms.
- 6.4 Nothing in these General Terms or any Content Specific Terms shall exclude or limit either party's liability for death or personal injury caused by its own negligence or for fraud or fraudulent misrepresentation.

NHS England's failure to exercise or enforce any right or provision of these General Terms or any Content Specific Terms shall not constitute a waiver of such right or provision.

7. Freedom of Information

- 7.1 The Licensee acknowledges that NHS England is subject to the requirements of the Freedom of Information Act 2000 ("FOIA") and may be required under the FOIA to disclose information without consulting or obtaining consent from the Licensee.
- 7.2 The Licensee shall provide assistance and cooperation as reasonably requested by NHS England to enable NHS England (acting in its full discretion) to comply with its obligations under the FOIA and shall not respond directly to a request for information pursuant to the FOIA unless authorised in writing to do so by NHS England.
- 8. Assignment and other dealings**
- 8.1 The Licensee may not assign, transfer, novate, sub-contract, mortgage, charge or otherwise deal with its rights and obligations under these General Terms or any Content Specific Terms without the prior written consent of NHS England.
- 8.2 NHS England may assign, transfer, novate, sub-contract, mortgage, charge or otherwise deal with its rights and obligations under these General Terms and/or any Content Specific Terms to the Authority, an Authority Party or any other person involved in the Permitted Purpose. A change in the legal status of NHS England shall not affect the validity of these General Terms or any Content Specific Terms and these General Terms and any Content Specific Terms shall be binding on any successor body or bodies to NHS England.
- 8.3 Reference in these General Terms and any Content Specific Terms to a party shall, upon any assignment or other transfer permitted by these General Terms, be construed to include those successors and permitted assigns or transferees.
- 9. Severability**
- 9.1 In the event that any provision of these General Terms and any Content Specific Terms shall be deemed contrary to law or invalid or unenforceable in any respect by a court, the remaining provisions shall not be affected, but shall, to the maximum extent permissible in law, remain in full force and effect and any invalid and/or unenforceable provision shall be modified or limited to the extent necessary to render the same valid and enforceable.
- 10. Entire Agreement**
- 10.1 Subject to clause 10.2 below, these General Terms and any Content Specific Terms set out the entire agreement and understanding between the parties in respect of its subject matter and replaces any previous agreement, warranty, statement, representation, undertaking or understanding (in each case whether written or oral) given or made before the date of these General Terms (and any Content Specific Terms) by, or on behalf of, the parties (or in the case of NHS England, by or on behalf of the Authority or any Authority Party) and relating to its subject matter. These General Terms and any Content Specific Terms do not create a partnership, joint venture, employment or any other agency or fiduciary relationship between the parties, the Authority or any Authority Party.
- 10.2 Where the Licensee is using Content previously licensed to it by the Authority or another Authority Party ("**Legacy Content**") nothing in these General Terms shall replace any previous agreement in place relating to use of that Legacy Content until such time as that Legacy Content is available to be issued directly by NHS England to the Licensee (through the Website or otherwise). Upon such availability and/or notification by NHS England or the Authority that any previous agreement relating to the Licensee's use of the Legacy Content is terminated, these General Terms and any Content Specific Terms will have automatic and immediate effect and shall replace any previous agreement in place in relation to that particular piece of Legacy Content (which shall then be considered "Content" for the purpose of these General Terms and any Content Specific Terms).
- 10.3 If any provisions of these General Terms or any Content Specific Terms are found to be invalid or unenforceable, but would cease to be invalid or unenforceable if some part were deleted, the term in question shall apply with such modification as may be necessary, and any invalidity or unenforceability

- 10.3 If any provisions of these General Terms or any Content Specific Terms are found to be invalid or unenforceable, but would cease to be invalid or unenforceable if some part were deleted, the term in question shall apply with such modification as may be necessary, and any invalidity or unenforceability shall not affect the other terms of these General Terms or any Content Specific Terms, which shall remain in full force and effect.
- 10.4 NHS England reserves the right to amend the provisions of these General Terms and/or any Content Specific Terms from time to time and to change the way in which the Content is made available to the Licensee and it is the Licensee's responsibility to ensure that they agree to and comply with the latest version of these General Terms (including executing any future version of these General Terms if required by NHS England) and any Content Specific Terms.

11. Counterparts

- 11.1 These General Terms may be executed in any number of counterparts, each of which is an original and all of which taken together shall constitute one and the same agreement.

12. Third Party Rights

- 12.1 Save for the Authority and any person to whom the benefit of these General Terms and any Content Specific Terms is assigned or transferred, it is agreed for the purposes of the Contracts (Rights of Third Parties) Act 1999 that these General Terms and any Content Specific Terms are not intended to, and do not, give to any person who is not a party to them any rights to enforce them, but nothing shall affect any right or remedy of any person which exists or is available other than pursuant to the Contracts (Rights of Third Parties) Act 1999.

13. Governing Law and Jurisdiction

- 13.1 These General Terms (and any Content Specific Terms) shall be governed by and interpreted in accordance with English law and the English courts shall have exclusive jurisdiction to settle any dispute, controversy or claim arising under or in connection with these General Terms (and any Content Specific Terms) (including regarding its existence, validity or termination).
